CAPT John Heinzel New Post President RVP Mike Blount Inducts Officers, Directors for 2011-12 Term

"The admiral shared his three SAME focus goals for the Society's 28,000 members, stressing support for the Wounded Warriors program," said Regional Vice President Mike Blount, keynote speaker and installation officer for the Jacksonville Post's installation meeting at Naval Air Station Jacksonville on July 14, 2011. The admiral he is referring to is ADM Christopher Mossey, newly appointed SAME President, who shared his goals for the Society at the recent 2011 JETC in Grapevine, Texas. "As usual, Jax Post is already on track with golf tournament proceeds benefiting the program earlier this year," said Blount. He went on to talk about the Jax Post's many achievements during the year. Blount presented out-going Jax President, COL Al Pantano, the Distinguished Post Streamer award while honoring Jax as the only post in the region to earn all streamers with distinction. 

Jax Post Honors Excellence

Engineer of the Year - Laureen Borochaner

Currently detailed as Deputy Chief overseeing Project Execution and Development of Quality Management System. Since early April a total of 27 process documents that address Financial Management/Tracking, Project Execution and Quality Management have been developed. This is a first of its kind within SAD.

Sponsor liaison and technical oversight for major Jacksonville District programs including the South Florida Everglades Ecosystem Restoration Program.

Responsible for design and oversight of major District projects including: HHD Culvert Project. Phase 1 of this estimated overall \$700M project which includes removal or replacement of up to 32 large water control structures in the HHD embankment was completed on an accelerated scheduled for September 2011 award.

Site 1 Project. An estimated \$200M, 1,660 acre above ground reservoir and associated pump stations and control structures. Phase 1 for this project is currently under construction with phase 2 design just completed.

Indian River Lagoon Estuary Project. An estimated \$450M combination of reservoir, storm water treatment areas and associated pump stations and control structures that will redirect and retain water and improve degraded water quality. Contract 1 construction and contract 2 design will be awarded this year.

Member and director of SAME Jax Post since 2005. Roles have included Chair of Outreach and Communication Committee and Education and Mentoring Committee. Responsible for identifying and recommending high-performing high school students for SAME JAX Post sponsorship to attend Engineering and Construction Camps, NE Florida Science Fair, Scholarships, and Post Outreach and Scholarship Budgets. Received the Post President's Award in 2010.

Young Engineer of the Year - Autumn Ziegler

Despite her relative inexperience as a Senior Engineer, Autumn has performed superbly as Engineering Technical Leader (ETL) for the \$53M Merritt Pump Station, \$79M Faka Union Pump Station and \$65M Miller Pump Station. All three of these projects are part of the Picayune Strand Restoration Project in Collier County, Florida, part of the Comprehensive Everglades Restoration Plan (CERP)

For Merritt Pump Station, her major work has been in coordinating, scoping, and negotiating modifications that are a result of sponsor requested changes for the pump station.

For the Miller Pump Station, currently being designed in-house, she coordinates with the sponsor for design requirements, manages design team in preparation of plans and specifications, and develops schedules and budgets for project.

For the Faka Union Pump Station, she developed a thorough matrix that was used to track questions from contractors that were submitted during the advertisement period.

Getting to Know New Post President— CAPT John Heinzel

Captain Heinzel assumed command of Naval Facilities Engineering Command (NAVFAC) Southeast on July 23, 2010 having completed a tour as Commanding Officer Center for Seabees and Facilities Engineering and Civil Engineer Corps Officer School and COMPACFLT Deputy Fleet Civil Engineer and Director of Fleet Support.

He obtained his Bachelor's degree in 1983 from Pennsylvania State University in Petroleum and Natural Gas Engineering. CAPT Heinzel also holds a Masters of Science degree in Civil Engineering, majoring in Construction Management, from the University of California at Berkeley, and he attended the Executive Program at the Ross Business School, University of Michigan graduating in 2005.

He was commissioned as Ensign, Civil Engineer Corps, United States Navy in August 1984, and his first assignment was Assistant Resident Officer in Charge of Construction at Andrews Air Force Base, Camp Springs, Maryland. In November 1986, he transferred to the Washington Navy Yard Public Works Department, Washington, D.C., as Activity Liaison Officer and also served as director of pre-award actions in the contracts department. In March 1987, he was assigned as the Civil Engineer Corps Accessions Officer for the Eastern U.S.

Captain Heinzel's first seabee tour was with NMCB THREE in June 1990, where he served as Bravo, Alfa and Echo Companies Commander and Det Souda Bay Officer in Charge (OIC), deploying to Rota, Spain; Guam; Subic Bay, Republic of the Philippines; and Souda Bay, Crete, Greece. After his mobile tour, he reported to the THIRTY-FIRST Naval Construction Regiment as Readiness and Embark Officer.

In April 1995, following his Seabee tours, CAPT Heinzel served in a joint tour as Military Engineer, U.S. Special Operations Command, MacDill Air Force Base, Tampa, Florida. In July 1998, he reported to Public Works Center, Guam, as the Production Officer, and in September 2000, he took over as Operations Officer, Engineering Field Activity, Chesapeake, Washington Navy Yard, D.C.

CAPT Heinzel returned to the Seabees when he assumed command of NMCB ONE in May of 2002 and led deployments to Okinawa, Japan, Guam and Rota, Spain. NMCB ONE sent detachments in direct support of both Operation Enduring Freedom, Philippines and Operation Iraqi Freedom II. NMCB ONE was named



FY2004 Atlantic Fleet Best of Type and also awarded the Peltier Award for best battalion in the NCF.

CAPT Heinzel's decorations include the Legion of Merit, Defense Meritorious Service Medal, Meritorious Service Medal (three), Navy and Marine Corps Commendation Medal (two), and Navy and Marine Corps Achievement Medal (two). He is a Seabee Combat Warfare Officer, Navy Parachutist, Acquisition Professional, and a Licensed Professional Civil Engineer in the State of Florida.
